#### DESCRIPTION

Attractive entrance door with glazed side panel.

Porch with marble floor and further door leading to a bright and welcoming hallway with tiled floor.

Doors leading to all four bedrooms and the family bathroom.

Opening to the large, open plan, 'L' shaped living area which encompasses a spacious rectangular living room with exposed brick fireplace and wood burner, spacious dining room and sizeable kitchen with breakfast bar.

The living and dining areas feature an engineered wooden floor and the kitchen has a ceramic tiled floor.

The dining area also has picture windows overlooking the garden and a door opening onto the sheltered veranda.

The kitchen, with peninsula breakfast bar, has work tops on three sides and an array of wall and base units.

There is space for a Range style oven and integrated appliances include a dishwasher and washing machine.

## GROUNDS.

The house sits in an elevated position and is approached via a sweeping driveway, towards to the top of which sits generous parking for several cars.

To the rear, there is a beautiful and mature garden which in addition to a wide variety of plants and shrubs, hosts a variety of fruit trees.

Beyond the formal grounds sits a further plot of land which would be ideal for recreational use, a kitchen garden or equestrian purposes.

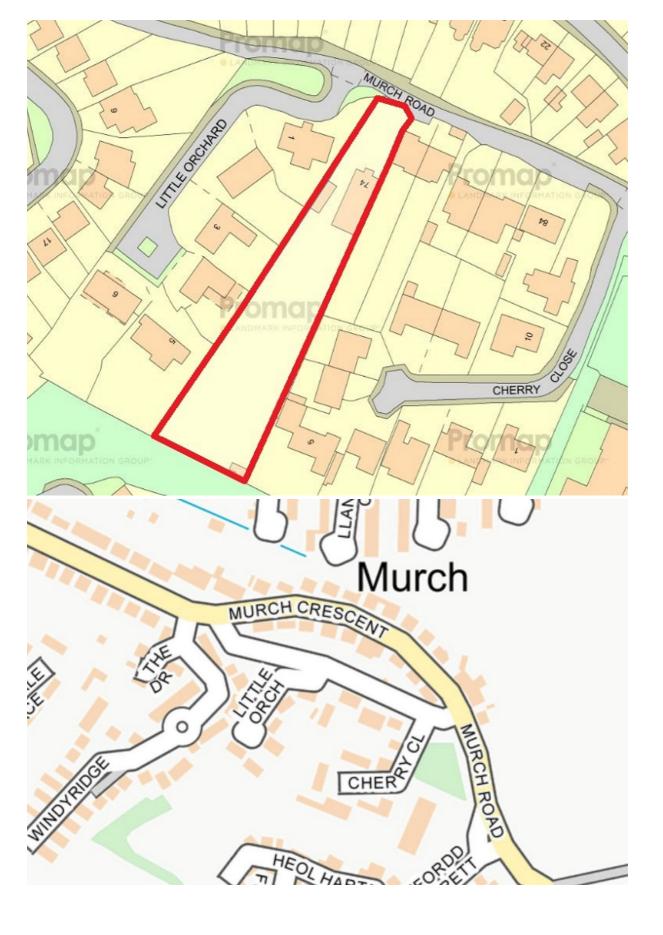
