#### **GROUND FLOOR**

A wooden entrance door with glazed side panel sits beneath the car port and leads to a well lit inner hallway with doors leading to the open plan living area, kitchen and cloakroom.

Stairs, with feature balustrade, rise to the first floor.

The large open plan living and dining area has a sunny aspect and beautiful vista across the Old Harbour with its stunning beach.

A ceramic tile floor runs throughout and sliding patio doors open onto the terrace.

The modern and sleek kitchen is well equipped and has been recently updated with an array of wall and base units, work tops on three sides, double sink unit and moveable island.

The space has a built in oven and gas bob with extractor hood.

There is also space for a fridge, freezer and washing machine.

Windows overlook the frontage and a door opens onto a private courtyard.

A cloakroom with WC and wash hand basin completes the ground floor accommodation.

## FIRST FLOOR

The first floor hosts two bedrooms and a bathroom located off a generous landing which could be sub-divided to offer a concealed storage area or study with front window.

Handy storage cupboards are also accessible off the half landing.

The master bedroom features a large, arched, picture window with tremendous view and features an en-suite bathroom with shower, WC and vanity wash hand basin.

Bedroom 2 has a Juliet balcony with sea view.

A modern and stylish bathroom with bath, WC and wash hand basin completes the first floor accommodation.
