o Kitchen with wall and base units, work tops, double sink unit, fitted electric oven with electric hob and extractor hood over. Also space / plumbing for appliances including a washing machine and fridge / freezer

o Carpeted master bedroom with view across the village square and war memorial

o Carpeted second double bedroom also with view across the village square


